

Minutes of the Meeting of the Committee held at 11:00 AM on 12 February 2026 to assess the suitability of applicants for appointment on compassionate ground in this Ministry for one vacancy in the post of MTS.

A meeting of the Committee constituted for the purpose of consideration of compassionate appointment cases in this Ministry was held at 11:00 AM on 12.02.2026 under the chairmanship of Shri Yash Veer Singh, Director (Estt.). The cases of the following dependent family members were considered:

1. Shri Rahul Attree s/o Late Shri Rajinder Singh, Ex-SCD
2. Ms. Meenakshi wife of Late Shri Sidhant, Ex-JSA
3. Shri Arun Yadav s/o Late Shri Ram Dev Yadav, Ex-MTS
4. Shri Mridul Vashishth s/o Late Smt. Simmi Vashistha Pooja, Ex-JSA

2. At the outset, the committee was apprised with the gist of applications received, consolidated instructions on compassionate appointment by DoPT, duly filled in proforma from the Applicants, Inspection reports from Welfare Officer, Consolidated report of applicants (Annexure I) and weighted points in 100-point format as approved by the competent authority in the Ministry of Culture (Annexure II).

3. The Committee was then informed that the objective of the Scheme for compassionate appointment is to grant appointment on compassionate grounds to a dependent family member of a government servant dying in harness thereby leaving his family in penury and without any means of livelihood, to relieve the family of the Government servant concerned from financial destitution and to help it get over the emergency.

4. The Committee has considered the cases on the basis of 100 points format for comparative analysis to examine their selection and the details of the weighted points obtained by all the 04 applicants on the basis of these criteria are given at Annexure III. The summary of the weighted points is as under:




