- (iii) Utilization Certificate (in 12-A format of GFR-2017) from the chartered accountant certifying that the amount of second installment has been fully utilized.
- (iv) Certificate from the chartered accountant that the organisation has spent corresponding amount of its matching share.
- (v) Completion certificate issued by appropriate civic authority or copy of a letter of the organization to the civic authority informing about the completion of the project (in case of new construction).
- (vi) Any other document as requested by the Central Govt. from time to time.
